/ Both parties hereby agree to the following terms and conditions:

1. Tuition:

- Payments will be made on a monthly basis.
- These payments will come out automatically with a card on file on the 5th of every month.
- If the card is declined and is not remedied by the 15th of the month there will be a late fee added in the amount of \$25.
- If tuition is not paid by the 5th of the month, the JCC has the option to suspend lessons until balance is paid.
- A \$25 recital fee will be added to your balance the month of recital if the student is participating.
- Pricing
 - o Members
 - 30 minutes: \$138/mo
 - 45 minutes: \$185/mo
 - 60 minutes: \$250/mo
 - Non Members
 - **3**0 minutes: \$184/mo
 - 45 minutes: \$250/mo
 - 60 minutes: \$338/mo

2. Attendance:

- Two no-shows in a semester will risk forfeiting your lesson time
- If the student is going to be absent, the student/parent must email by **6:00pm** the day prior of the scheduled lesson **to both** of the following emails in order to not count as a no-show
 - sknauss@jccomaha.org & ekatz@jccomaha.org
 - Voicemails will not count as a cancelation as we are not always in the office to receive the message
- You can schedule **one** makeup lesson a month <u>only</u> if notice of your absence is given no less than one week in advance.
- If the JCC cancels a piano lesson, that lesson will be used as credit towards the next month's payment. No credits will be given for absences.

3. Absences

- An absence is treated differently than a no-show
 - o A no-show is when we receive notice the day of the lesson, or receive no notice at all.
 - o An absence is when we receive notice at least one day before the scheduled lesson.
 - o Absences will not be counted as one of your no-shows
- No refunds or credits will be given for absences or no-shows. You have reserved that time and space for the entire month.
- No lessons will be credited unless canceled by the JCC.
- When committing to lessons, the JCC Performing Arts Department is reserving a specific day/time for you that cannot be filled by other customers/students. Therefore, you are not only paying for each individual lesson that occurs, but for that time slot. Your lesson rate includes all of the following:

4. Discontinuation of Lessons:

- If a student chooses to discontinue lessons, we must receive a two-week <u>written</u> notification by the 15th of the month
- Failure to notify us by the 15th will result in being charged an early cancelation fee
 - \$55 for members
 - \$72 for non-members
